Introduction

Following the Memorandum of Understanding signed in August 22, 2006, the UIA and the All China Lawyers Association (ACLA) have joined forces to organise this seminar that is designed to offer a unique opportunity to participants to receive an intensive briefing on key legal aspects of Chinese Law and on their interaction with foreign legal rules in dealings with China.
